



# Policy – Privacy Statement

The Gorge Soccer Association (Gorge) has created this privacy statement in order to demonstrate our firm commitment to privacy. The following discloses our information gathering and dissemination practices.

## INTRODUCTION

Information provided to Gorge Soccer Association (Gorge) is collected as part of our player, coaching and team management process. The information will be used solely for purposes related to the daily operation of our soccer programs and is subject to the rules contained in the British Columbia Personal Information Privacy Act (PIPA). A copy of the LISA Rule 1300 describes how your information will be used and protected. ## INFORMATION COLLECTION AND USE

The only personal information Gorge has regarding members is the information provided by members when applying for membership and registering for programs through the organization.

In registering for a program, you consent to the Club's use of your personal information for purposes of membership and for purposes of the administration of the particular program that is being accessed. In particular, you consent to having your personal information used and published in member lists, contact lists, volunteer lists, team lists, coach lists, and such other documents as may reasonably be required in the operation of the Club and the programs that it administers or is involved in.

Your personal information will not be distributed to third parties except as required in connection with the operation of the Club and the programs that it administers or is involved in. This would include the sharing of information with Lower Island Soccer Association for the



purposes of registration with them where applicable, and with the community association designated during registration for the purposes of confirming or arranging for membership.

## **CONFIDENTIALITY**

Your personal information (e-mail, name, address, telephone number) is not transferred to the third party. The Club will not use personally identifiable information of children. Your information will never be sold, rented, loaned or made available in any manner to any third party.

The Club may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you.

Gorge Soccer may collect, use, or disclose personal information without consent where reasonable to do so and where permitted under PIPA or by law. By providing personal information to Lower Island Soccer Association and BC Soccer, and participating in its programs and activities, individuals are considered to have consented to the use of the information in the manner and for the purposes identified in this policy.

Registration information is used to allow the Club to communicate better with our customers. The information collected during registration enables us to give email subscribers current information updates regarding Club activities.
